#### 4.1. Description of first aid measures

#### **General information**

#### 4.2. Most important symptoms and effects, both acute and delayed

Neurotoxic effect: This product contains organic solvents, which can have an effect on the nervous



system. Symptoms of neurotoxicity can be: loss of appetite, headache, dizziness, whistling in the ears, tingling sensations in the skin, sensitivity to the cold, cramps, difficulty in concentrating, tiredness, etc. Repeated exposure to solvents can result in the breaking down of the skin's natural fat layer. The skin will then be more prone to absorb dangerous substances, e.g. allergens.
